Sh. Pawan Jaggi, Chairman, Governing Body welcomed all the members present in the meeting.

The Chairman apprised the members that a three-member Fact-Finding Committee, comprising Prof. Vipul Singh, University Representative on Governing Body and Mr. Rohit Sharma, Member G.B. with the Treasurer of the Governing Body as the Convener was constituted by the Chairman vide letter reference no. ARSD/GB dated 27.01.2023 to look into the complaints filed by Ms. Aruna Kumar (a suspended employee of the College) to various authorities which were received from the office of Chief Vigilance Officer, University of Delhi.

As per the recommendation of the committee, two more members, Prof. Hamendra Dangi, University Representative on Governing Body, and Prof. Anamika Parsad, Woman Member, were included in the Committee with the approval of the Chairman, vide letter ref no. 1670 dated 06.02.2023.

Subsequently, the Convener, Fact-Finding Committee, with the approval of the Chairman, G.B., invited Sh. Sharad Kumar Sant, Deputy Registrar (Finance), University of Delhi, Sh. Pradeep Kumar, Joint Registrar (Legal), D.U. and Dr. Rohan Rai, Joint Registrar (Establishment), D.U. to advise the committee on the matter related to finance and procurement, vide letter ref no. 1958 dated 27.02.2023, letter ref. no. 276 dated 06.05.2023 and letter ref no. 277 dated 06.05.2023 respectively.

The committee discussed and deliberated all the issues raised by Ms. Aruna Kumar, Sr. P.A. to Principal, in her complaints filed to various authorities through its successive meetings and

prepared its report. The same was submitted to the Chairman, Governing Body, vide letter reference no. 188 dated 08/08/2023 by Sh. Praveen Seth, Treasurer and Convener of the Fact-Finding Committee

The report of the Fact-Finding Committee was placed before the Governing Body, and was discussed and deliberated at length. The Governing Body unanimously resolved the following:

1. Upon the perusal of the report of the Fact-Finding Committee submitted, the Governing Body is of the opinion that the outcome of the report is appropriate. Accordingly, the Governing Body resolved that the report of the Fact-Finding Committee be approved.
2. The Governing Body unanimously resolved that the complaints filed by Ms. Aruna Kumar to various authorities are *mala fide*, arbitrary, frivolous, misleading and factually incorrect.
3. The Governing Body unanimously endorsed the conclusions of the Fact-Finding committee in totality and resolved that no further action is required on the frivolous, misleading and factually incorrect complaints filed by Ms. Aruna Kumar.
4. The Governing Body further resolved that the Chairman, G.B., may send the concluding report to the office of the Chief Vigilance Officer, University of Delhi, for information and further advice.

The meeting ended with a vote of thanks to the Chair.




