Minutes:

Reference to the earlier 163rd meeting of the Governing Body held on 04.08.2022, Smt. Aruna Kumar Sr. P.A. to Principal was put under suspension vide office order ref. no.164 dated 04.08.2022. The Competent Authority extended her suspension for a period of 180 days w.e.f. 03.11.2022 vide office order ref. no.248 dated 28.10.2022.

Further Shri S.K. Tandon, Additional District and Session Judge (Retd.) was appointed as Enquiry Officer to hold the inquiry against the delinquent Smt. Aruna Kumar and submit his report after hearing the prosecution and counter evidences and documents by both sides.

On this matter the Chairman, Governing Body requested the Principal to apprise the present status of the case related to Smt. Aruna Kumar to the honourable members.

The Principal briefed to the honourable members regarding the present status of the case and recommendations of the Review Committee, the meeting of which was held on 10.04.2023. The Review Committee had recommended that in view of gravity of the offence and the present status of the case, and to avoid hampering in the smooth conduct of the departmental enquiry, the suspension period of Ms. Aruna Kumar Sr. P.A. to Principal may be extended for a further period of 180 days w.e.f. 02.05.2023.
