The Chairman, Governing Body welcomed all the members present in the meeting.

A letter bearing ref. no. 948 dated 19.10.2023 along with Inquiry Report dated 13.10.2023 was sent to Ms. Aruna Kumar, seeking her reply thereto within 15 days of the receipt of the said letter. Ms. Aruna Kumar submitted her reply to the Inquiry Report vide her letter diary no.-6050 dated 06.11.2023 to the Chairman, Governing Body which was placed before the Governing Body in its meeting on 25.11.2023 for deliberation by Members of the Governing Body.

The reply dated 06.11.2023 by Ms. Aruna Kumar against the Inquiry Report dated 13.10.2023 was discussed and considered by the Members of the Governing Body.

The University Representatives Prof. Vipul Singh and Prof. Hamendra Dangi advised to refer the reply submitted by Ms. Aruna Kumar to the University of Delhi but other members expressed their view that the Governing Body is an Appointing and Disciplinary Authority. Therefore, being a Competent Authority, Governing Body can take decision in the matter and

After due deliberation and discussion, the majority of Governing Body members (except University representatives Prof. Vipul Singh and Prof. Hamendra Dangi) have found no substance in the reply submitted by Ms. Aruna Kumar, the same is approved by majority (9:2) and decided to make an order in this regard. Accordingly, the office of the Chairman, Governing Body has been authorized by the Governing Body for preparing a draft order which shall be circulated to the members of GB before the meeting so that the same can be deliberated and considered for approval in the next Governing Body meeting.
